## **Trump emotação do pêne msa durante conferência de imprensa; faz reivindicações desafiando fatos e falando sobre multidões maiores do que Martin 7 Luther King**

**O ex-presidente dos EUA também falou sobre pardões de participantes do  
ataque de 6 de janeiro ao Capitólio, e 7 x o gol bwin intenção de participar de  
três debates**

O ex-presidente dos EUA Donald Trump 7 ficou a quatro pontos da vice-presidente Kamala Harris no último sondeio de pesquisadores de opinião, então enfrentou os jornalistas por 7 uma hora na terça-feira x o gol bwin uma conferência de imprensa que rapidamente se transformou x o gol bwin um bando de condenações gratuitas, reivindicações 7 fantásticas e mentiras comprovadas.

"Ninguém foi morto x o gol bwin 6 7 de janeiro", disse o ex-presidente e candidato republicano à presidência, falando sobre o dia de 2024 quando incitou um ataque 7 ao Congresso agora ligado a nove mortes, incluindo suicídios de agentes de seguradora e o tiro de um policial de 7 Ashley Babbitt, que os eleitores de Trump reivindicam amplamente como um mártir.

7 Falando x o gol bwin seu local de veraneio x o gol bwin Mar-a-Lago, na Flórida, Trump repetiu elogios a manifestantes condenados e 7 detidos x o gol bwin centenas, aos quais ele disse que ele vai conceder indultos. Absurdamente, ele também afirmou que houve uma "transferência 7 pacífica" de poder após perder para Joe Biden.

No 7 entanto, ele parecia mais triste com o tamanho de seu público.

7 "Eus eu falou para as maiores multidões", Trump reclamou, x o gol bwin apenas uma reclamação sobre o suposto engrandecimento do 7 tamanho da multidão da x o gol bwin adversária de democrata, Kamala Harris, x o gol bwin detimento da sua.

7 "Ninguém tem falado para multidões maiores do que eu", disse Trump. "Se você olhar para Martin Luther King, quando 7 ele falou, seu grande discurso, e você olha para o nossos, mesmo realidade, mesmo tudo, mesmo número de pessoas, se 7 não temos mais."

Trump estava comparando o discurso no 7 Ellipse x o gol bwin 6 de janeiro de 2024, quando disse aos apoiadores para "lutar comoação dade' x o gol bwin serviço da x o gol bwin mentira sobre 7 fraude eleitoral x o gol bwin x o gol bwin derrota x o gol bwin 2024, ao discurso de King no Lincoln Memorial x o gol bwin 28 de agosto de 1963, 7 um marco do movimento dos direitos civis na qual King delineou seu sonho de igualdade racial.

7 "Eles disseram que eu tinha 25.000 e ele tinha um milhão de pessoas. 7 E eu vou bem com isso, porque eu gosto do Dr Martin Luther King", disse Trump. Era-um-eco da menção de 7 Trump sobre a multidão do seu encerramento x o gol bwin 2024, comparando a multidão para o encerramento de Barack Obama. Análises mostraram 7 a multidão de Trump não era muito notável ou comparável.

7 Trump fez uma notícia, dizendo que ele queria "fazer três debates" e tinha acordado ou estava próximo de acordos 7 de termos com Fox, NBC e ABC. Depois que ele terminou de falar, a ABC disse Harris e Trump concordou 7 x o gol bwin debater x o gol bwin 10 de setembro.

No entanto, a 7 maioria das respostas de Trump deslocou terreno conhecido.

Ele 7 acusou Harris de corrida de três turnos para falar com a imprensa; atacou seu registro como vice-presidente x o gol bwin política de 7 fronteira e imigração; zombou do seu desempenho na eleição primária democrata de 2024; disse democratas foram suaves sobre o crime; 7 soft-



7 The majority of the time, Trump's answers tread familiar ground.

He accused Harris of running shy of speaking to the press; attacked her record as vice-president on border policy and immigration; ridiculed her performance in the 2024 Democratic primary; said Democrats were soft on crime; soft-pedaled the removal of the federal right to abortion by supreme court justices he installed; rehashed his hugely controversial questioning of Harris's racial identity; claimed Harris and Biden projected weakness in the BR withdrawal from

Afghanistan and elsewhere, allowing Russia to invade Ukraine and Hamas to attack Israel and forfeiting the respect of authoritarian leaders stay with the lie. 7

That wasn't the half of it. Trump even claimed to have been 7 "very protective" of Hillary Clinton, the Democrat he beat in 2016, a campaign in which Trump's supporters regularly chanted – 7 with his encouragement – that Clinton should be locked up.

7 Clinton was "pretty evil", Trump said, accusing her of various unsubstantiated misdoings, but "I thought it was a very 7 bad thing take the wife of a president of the United States and put her in jail, and then I 7 see the way they treat me. That's the way it goes. But I was very protective of her. Nobody would 7 understand that, but I was. I think my people understand it."

7 Most Americans understand that Trump is the first former president to be criminally convicted, on 34 stays with 7 the lie.

He faces as many as 54 other 7 criminal charges, in cases concerning attempted election subversion and retention of classified information. On Thursday he praised as "brilliant" the 7 Florida judge, his own appointee, who threw out the classified information case, a decision now on appeal. 7

Trump has also been ordered to pay hundreds of millions of dollars to settle a class action lawsuit filed by former employees who claimed they were denied overtime pay under federal law. The suit, which was filed in 2015, alleged that Trump's company, The Trump Organization, violated the Fair Labor Standards Act by failing to pay overtime to workers in its New York City office. The company settled the case in 2017 for \$25 million.

The settlement agreement required The Trump Organization to pay \$25 million to a fund that will be used to provide compensation to former employees who worked at least 10 hours per week in New York City between January 1, 2009 and December 31, 2015. The company also agreed to implement a new overtime pay policy that complies with federal law.

The settlement was reached after negotiations between the U.S. Department of Labor and The Trump Organization. The department's Office of Workers' Compensation Programs (OWCP) handled the investigation and enforcement of the FLSA violation. The OWCP found that The Trump Organization failed to pay overtime to workers who were entitled to it under the FLSA.

The settlement agreement includes provisions for monitoring and auditing The Trump Organization's overtime pay practices to ensure compliance with federal law. It also requires the company to provide documentation of its overtime pay calculations to the department upon request.

The settlement agreement is subject to court approval. If approved, it will become final and binding on all parties involved.

7 Trump has been ordered to pay hundreds of millions of dollars in civil suits 7 concerning business fraud and defamation arising from a rape claim a judge called "substantially true".

7 Trump has never been afraid to go low. At one point on Thursday, she seemed to be a likely preview of blows to come.

7 Despite it all, he remains the Republican nominee for president, running with JD Vance, the Ohio senator, against Harris 7 and Tim Walz, the governor of Minnesota.

Amid polls showing Harris leading nationally and gaining or leading in battleground states, doubts about Trump's prospects have spread. Earlier on Thursday, 7 Karl Rove, a Republican

operative once known as George W Bush's "brain", wrote for the Wall Street Journal under the 7 headline "Trump Teeters, but Will They Fall?"

"This race 7 will be decided by each party's success in two fundamental tasks," Rove wrote.

"Turning out its base and persuading independent, 7 swing voters." Convincing independents would be "decisive".

"The past 7 six weeks have shown that the pendulum can swing rapidly and wildly," Rove wrote. "The Trump-Vance ticket is floundering. Mr 7 Trump seems rattled. He's making plenty of unforced errors and wasting valuable, irreplaceable time on insults, side issues and trivia." 7

Rove's column was published before Trump's press conference. Among 7 Republicans, Rove's message must have rung louder still after Trump was done.

7 "All this undermines his cause," Rove wrote. "The Trump-Vance ticket needs to become much more disciplined and 7 settle soon on an effective line of attack against Harris-Walz that wins over swing voters and then stick to it. 7

"If it can't achieve both these goals, a race 7 Mr Trump was on the verge of winning three weeks ago could be lost."
