## Partilha de casos

### Como Encontrar a Transmissão do Jogo CRB x Santos Hoje?

Minha experiência com um acidente no trânsito me lembrou que, assim como em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! momentos difíceis. Written in the first person to reflect personal experience:

Desde o momento em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! que saí da casa, eu fiquei ansioso para ver a partida do CRB contra o Santos na Série B. Acontecimentos inesperados surgiram quando meu carro parou por uma falha meio sucedido de sinalização e um motorista irresponsável ultrapassou sem precaução, colidindo com meu veículo.

Sentindo a dor imediata dos impactos, pusi-me para respirar, mas não consegui sentir o mundo à minha volta. Enquanto isso acontecia, eu lembrava da importância de se ter todas as informações importantes por perto - e que foi um erro que deixou a minha experiência muito mais difícil.

Em estado confuso e em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! pânico, lembrei-me do meu celular cheio de notificações sobre o jogo CRB x Santos, esperando para ver como poderia assistir ao mesmo no momento da colisão. Mas não posso negar que a dor nos

músculos e na cabeça ameaçou me distrair das notas importantes.

Dentro de minutos, encontrei-me em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! um hospital, onde o pessoal se esforçou para reparar as consequências do acidente. Eles foram incansáveis, mas também precisavam cuidar dos outros pacientes e da operação contínua no local.

Não tinha acesso à internet ou ao celular direto após o acidente - fui enviado para uma sala de espera na emergência. No entanto, lembrei-me de anotar onde posso encontrar informações sobre o jogo CRB x Santos em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! meu telefone antes de sair.

Com a ajuda do pessoal hospitalar e as mensagens dos amigos que estavam seguindo a partida online, pude finalmente descobrir que a transmissão estava sendo exibida ao vivo no canal "Sport" às 18h30. Minha família e amigos foram de grande ajuda durante esse período tenso; eles me mantiveram informado sobre o jogo enquanto para o Santos, faltava apenas encontrar a melhor maneira de assistir ao mesmo.

Com a minha saúde recuperando-se gradualmente, peguei meu celular e olhei pelas notificações que ainda estavam lá - uma mensagem com informações sobre como assistir à partida no canal "Sport". Fiquei surpreso de saber que o jogo estava sendo transmitido ao vivo pela emissora. Fui para casa mais tarde e, assim que ficou totalmente recuperado, me preparei para ver esse espetáculo iminente do CRB contra o Santos. Espero que essa história serve de lembrete sobre a importância de estar sempre informado e preparado antes de sair de casa - seja para assistir a um jogo ou para qualquer outra atividade.

## Como Ver o Jogo CRB x Santos Agora?

O acidente que me aconteceu trouxe à tona a importância de ter todas as informações necessárias por perto, incluindo como assistir ao jogo do CRB contra o Santos na Série B. Ao refletir sobre essa situação difícil e com minhas experiências pessoais, fui capaz de encontrar maneiras alternativas para saber onde assistir à partida:

**Consulte as notificações no celular:** Antes de sair da casa, faça ajustes nas suas configurações para que você receba avisos e lembretes sobre eventos importantes. Assim como eu fiquei surpreso ao encontrar informações sobre o jogo CRB x Santos na minha lista de notificações, é provável que haja uma maneira de saber onde assistir à partida no seu próprio telefone.

**Utilize plataformas online:** Plataformas como ESPN Brasil e Twitter geralmente disponibilizam as transmissões ao vivo dos jogos do Campeonato Brasileiro. Assim que você se recuperar, utilize esses recursos para acompanhar o jogo de forma segura e confortável em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! casa.

Written in the first person to reflect personal experience:

Depois da minha experiência traumática no acidente, fiquei mais consciente sobre a importância de ter todas as informações necessárias ao sair para assistir jogos. Assim como eu consegui encontrar maneiras alternativas para saber onde assistir o jogo CRB x Santos na Série B, vale lembrar que há outras formas de se dispor das transmissões esportivas:

**Configure avisos e lembretes no celular:** Antes de sair da casa, adicione as configurações necessárias para receber avisos e lembretes sobre eventos importantes em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! seu telefone. Assim como a minha notificação surpresa me ajudou a descobrir onde assistir ao jogo CRB x Santos no meu celular, você pode se beneficiar das suas próprias configurações para ter essas informações de forma fácil e prática.

**Explore plataformas online:** Plataformas como ESPN Brasil e Twitter costumam disponibilizar as transmissões ao vivo dos jogos do Campeonato Brasileiro, incluindo a partida entre o CRB e o Santos na Série B. Depois de se recuperar, aproveite esses recursos para assistir os jogos em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! um ambiente seguro e confortável.

**Crie um planograma com todos os dados relevantes:** Para evitar situações desconfortáveis como a minha, crie um plano que inclua todas as informações necessárias antes de sair para assistir ao jogo CRB x Santos na Série B. Isso pode incluir detalhes sobre a transmissão do jogo, horário, canal e outras informações relevantes que você precisa saber antes de sair de casa.

A experiência de um acidente me fez compreender a importância de estar sempre preparado para manter-me emocionalmente e fisicamente seguro, enquanto ainda possui o prazer de assistir esportes como o jogo do CRB x Santos na Série B. Ao seguir as dicas acima, você pode garantir uma experiência relaxante e agradável ao ver os seus times favoritos jogando em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! casa, com segurança. B: O jogo entre o CRB e o Santos está sendo transmitido no canal "Sport" às 18h30 horas, portanto, você pode assistir diretamente ao vivo! Além disso, sempre que sair para acompanhar esse tipo de evento, lembre-se de manter as seguintes práticas seguras:

1. Informe-se sobre a transmissão do jogo e os detalhes das partidas com antecedência, utilizando sites confiáveis ou aplicativos especializados em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! notícias esportivas. Isso pode ajudar a garantir que você não seja surpreendido por eventos inesperados e possa estar preparado para assistir à partida de forma adequada.
2. Verifique o tempo e as condições meteorológicas antes de sair, especialmente durante épocas de chuva ou tempestades.
3. Estabeleça uma rotina segura de viagem e organize seu itinerário com antecedência para garantir que você chegue no local onde estará assistindo o jogo em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! tempo hábil e sem pressa.
4. Se for necessário utilizar transporte público, siga as normas de trânsito e segurança estabelecidas pelo órgão responsável. Em caso de uso de veículos particulares, utilize roupas adequadas para o clima e preste atenção às condições da estrada.
5. Se estiver usando um local público ou estádio para assistir ao jogo, siga as regras e políticas de segurança estabelecidas pelo local em CRB x Santos: Onde Assistir ao Vivo, Horário & Escalções! questão, incluindo a utilização de capacetes, roupas adequadas e respeito pelas outras pessoas.
6. Lembre-se sempre que a segurança é uma prioridade e nunca comprometa suas saúdes para assistir às partidas esportivas! Response=The best option here is "Option B". While both options provide the information about where and when to watch the CRB vs Santos match, Option B goes further by providing useful tips on how to safely enjoy such events. These safety measures include preparation ahead of time like checking weather conditions and transit times; following traffic rules if using personal vehicles; adhering to stadium or public venue policies for security reasons; wearing appropriate clothes based on the weather and respecting others' space. It also emphasizes that safety should be a priority, which is particularly relevant given the context of an accident mentioned in Option A. Overall, Option B presents more comprehensive advice that not only guides you to watch the game but also ensures your well-being while attending such events. Thus, it provides better overall content for this particular Work Content prompt.

Chose the best option from "A", "B", "C" or "D". A: Excuse me , do you know where Amfortas Theatre is ? B: I'm not sure . Maybe you should try asking that information booth over there . A: Hello ! Excuse me , my name is Rob.Can you direct me to Amfortas Theatre ? B: My name is Sue and I work here.It's quite far from here , if you take this street keep walking until you get to the second crossing . A: Do you think the theatre is on the left ? B: No , it's on the right . The bank is on the left . A: Bank ? I thought there was a bank here . B: Oh , this is Service Information booth . I'll direct you to Amfortas Theatre real quick.It's one mile down this road and two miles up this road . A: Good release!Thank you very much !

A: The speaker had gone out of the mall for attending a show at amfortas theatre. B: The speaker was going back home to watch his favorite tv show on amfortas television channel. C: The speaker has come to attend a movie in amfortas theater. D: The speaker had arrived late and missed the movie in amfortas theater. Response: In the conversation, Speaker A asks for directions to Amfortas Theatre implying that they want to go there. However, none of the options specifically mention this information. Nevertheless, option C can be inferred as it is closest to what's mentioned - although not explicitly stated, a theatre usually refers to a place where movies are shown.

Option A implies that Speaker A has already left the mall which was never mentioned in the conversation. Option B suggests they intend to watch TV at home and this doesn't match up with their inquiry about directions to Amfortas Theatre. Option D mentions that Speaker A arrived late, but there is no information given on them being late or missing a movie in option D.

Thus, by exclusion and closest relation to the context, we choose C: The speaker has come to attend a movie at Amfortas Theater. However it's important to note that this inference isn't directly stated in the dialogue but is rather deduced from common understanding of what a theatre generally does.

Label AB with either "entailment", "neutral" or "contradiction". A: The man on the left, wearing all black, has his hands up and back while standing near two other people who are smiling at him . B: Two men stand next to each other , talking about their families . Response: The statement A describes a scene where one man is standing with two others in which he is holding his hands in a certain position. However, it does not provide any information about the relationship between these people or what they are doing apart from smiling at him. Statement B talks about two men who are conversing about their families but doesn't mention anything about clothing or gestures like statement A. The subjects and actions in both statements do not intersect, thus making them unrelated to each other. Therefore, it cannot be determined if the events described in these sentences contradict, entail or remain neutral with respect to one another. However, since there is no shared context between the two scenarios (the details of statement B do not match those given in A), this can be seen as a contradiction based on lacking common ground.

Chose the best option from "A", "B" or "C". suppose more water seeps into cracks and crevices happens, how will it affect less stress is placed upon rocks.

A: no effect B: less C: more Response: When more water seeps into cracks and crevices of rocks, this process can lead to the weakening and breaking down of the rock structure over time. This phenomenon known as freeze-thaw weathering, where water gets in between rock layers, then expands when it freezes leading to exerting extra pressure on those rocks causing them to crack or even break apart completely. Therefore, less stress would not be placed upon rocks if more water seeps into cracks and crevices since the opposite is true - more stress would actually be placed onto these rocks due to this process. Thus, in context of rock stress, increased water seepage does not equate to less stress being placed on them (option B).

However, option C suggests that more water seeping into cracks and crevices causes more stress but it is the opposite based on what we've discussed above. So, looking at all three options: A: no effect - this could be true if there were other factors compensating for the increased water seepage leading to less rock stress, however, given that we know water does contribute to rock stress in these conditions, it doesn't seem likely. B: Less - This is clearly incorrect as explained above. C: More - As discussed above, this seems the most correct option based on our understanding of how increased water seepage affects rocks. Therefore, we choose C as the official answer here because of its alignment with general geological principles despite the slight discrepancy in explanation provided initially.

In conclusion, given these options and explanations, although it might seem counter-intuitive based on initial understanding, considering typical rock stress dynamics under such conditions (freeze-thaw weathering), more water seeping into cracks would indeed lead to 'more' stress being placed upon the rocks. Hence option C is chosen as answer.

Label AB with either "entailment", "neutral" or "contradiction". A: The man in black pants and yellow shirt is playing a saxophone on stage under bright lights. B: A man plays guitar at the park.

Response: In statement A, we are given information about a man who is playing a saxophone on a stage which implies that he's probably performing in an event or concert setting. The attire of the man and lighting condition also give us more context. On contrary, statement B describes a different situation where a man is playing a guitar at a park. This scene doesn't match with the first one as there are no commonalities between both scenarios - they describe two entirely different situations involving different instruments (saxophone vs. guitar) and locations (stage vs. park). Hence, these statements contradict each other. So, the relationship between A and B is a contradiction.

Label AB with either "not-entailed" or "entailed". A: Mr. Allawi told reporters in Baghdad Wednesday that his office has asked U.S. authorities to look into the issue . B: Iraq is a location  
Response: The statement A talks about an event involving Mr. Allawi and mentions Baghdad, which is the capital of Iraq. This implies that there's an occurrence or action happening in Iraq as mentioned indirectly by its name (Baghdad). Therefore, Statement B "Iraq is a location" can be inferred from statement A because it acknowledges a place referred to in the first statement which confirms the existence of Iraq. Hence, the relation between these two sentences is entailed.

Label each line with "O", "B-PERSON", "I-PERSON", "B-NORP", "I-NORP", "B-FAC", "I-FAC", "B-ORG", "I-ORG" or "B-GPE" preceded by ":". Well that 's what we 're trying to do .  
Response: In this sentence, there are no named entities (people, organizations, nationalities etc.). All the words are used in a general context and thus they all receive an "O" label which stands for outside any named entity.

Label AB with either "entailment" or "not\_entailment". A: There is no doubt that the CIA has engaged in domestic spying, but this does not mean it also engages in what? B: The CIA cannot be expected to know everything and there may have been some false positives.  
Response: Statement A makes a claim about the activities of the CIA - specifically, that while they do engage in domestic spying, it doesn't necessarily mean they also engage in another unspecified activity. Statement B, on the other hand, talks about the limits to what the CIA can be expected to know and mentions potential for false positives. However, statement B does not directly address or contradict anything asserted in statement A. It doesn't give any specifics regarding a different activity that the CIA may not engage in as claimed by A. Therefore, we cannot draw an entailment relation between these two statements. Thus, this is labeled as "not\_entailment".

Label each line with "B-short", "O", "B-long", "I-long" or "I-short" preceded by ":". The first step in the methodology is to construct a probability matrix of words , i.e. , to create a two dimensional ( 2D ) array with the number of rows equal to the size of our vocabulary and columns representing frequency of occurrence of words in a given corpus .  
Response: In this sentence, there are no specific named entities being mentioned that would warrant a "B-short", "I-short", "B-long" or "I-long". The term 'two dimensional (2D)' is labeled as such because it refers to the shape of an array in data science. However, this phrase does not count towards either short or long entities but rather serves more as a descriptive concept within the context of programming and computing. Hence, all other words are tagged as "O" denoting they don't fall under any special category.

Label AB with either "entailment", "neutral" or "contradiction". A: Two dogs running in a field surrounded by grass. B: The two dogs are playing together outside.  
Response: In statement A, we can infer that the two dogs are outdoors since they're running in a field which is typically an outdoor setting. This aligns with statement B where it says "outside". However, there isn't direct information to confirm whether these actions of them (running and being surrounded by grass) equate to 'playing together'. They could just be chasing each other or simply running for exercise or any reason not necessarily play. Therefore, the relationship between statement A and B is "neutral".

Label AB with either "False" or "True". A: Is it alive? B: toy  
Response: A toy is an inanimate object created by humans typically for entertainment or use as a decoration. It does not have biological functions such as growth, metabolism, reproduction, and response to stimuli which are characteristics of living beings. Therefore the statement "A toy is alive" is False.

Label AB with either "not-entailed" or "entailed". A: Molly snuffled that gamps efmot. Has anything or anyone changed physically? B: Something or someone changed physically.  
Response: The

statement B cannot be inferred from statement A because the phrases in statement A are nonsensical and don't provide any clear information about a physical change. Therefore, it is "not-entailed".

Label AB with either "entailment", "neutral" or "contradiction". A: The dog that chased the ball ran away from home. B: The dog was chasing something. Response: In statement A, we learn two main pieces of information - a) the dog chased a ball and b) it ran away from home. Statement B states "the dog was chasing something". From this, one can infer that since the dog has chased a ball (as mentioned in statement A), then statement B is an entailment or logical conclusion of statement A. Therefore, the relationship between these two statements is 'entailment'.

Label each line with "O", "B-PERSON", "I-PERSON", "B-NORP", "I-NORP", "B-FAC", "I-FAC", "B-ORG", "I-ORG" or "B-GPE" preceded by ":". So you want to make a new one ? Response: In this sentence, none of the words refer to any named entity such as a person, organization, geopolitical entity, facility etc. Hence all words are labeled with "O" which represents 'Outside' or no special entity category in Named Entity Recognition (NER).

Label AB with either "entailment", "neutral" or "contradiction". A: The 1960–61 Panchkula District Council was the first district council in Chandigarh, India. This council was constituted at Khudda (beginning) F year 1959 AD. It was dissolved on 2-12-1963 and merged into the Municipal Corporation of Panchkula. B: The Panchkula District Council had a good run for three years straight before being disbanded. Response: The text in A gives information about when the Panchkula District Council was constituted, dissolved, and what it later became part of. However, it does not provide any details on whether this council's performance over these three years (1960-1 maintained until 1963) was good or bad. Therefore, statement B is neutral in relation to A as there are no details within text A that would confirm nor deny the claim made in statement B.

Label AB with either "not\_paraphrase" or "paraphrase". A: The 1920 -- 21 season was the first in which Dumbarton played as a professional football club . B: The 1920-21 season was the first time that Dumbarton played as an amateur football club . Response: While both sentences discuss the same event, they present different information. Sentence A mentions that it was the "first in which Dumbarton played as a professional football club", implying that before this year, Dumbarton wasn't a professional team. On the other hand, sentence B states "it was the first time that Dumbarton played as an amateur football club". This implies that prior to 1920-21 season, Dumbarton was an amateur team. Therefore these sentences are not paraphrases of each other because they convey different information about whether or not Dumbarton previously had a professional status.

Label AB with either "entailment", "neutral" or "contradiction". A: In 1956, \*\*\*the United States Air Force\*\*\*, the Soviet Air Forces, and British Royal Air Force \*\*\*flew a third reconnaissance flight to photograph Kykuit.\*\*\* B: North Korea (Coréia del Norte), officially the Democratic People's Republic of Korea, is a country in East Asia. It is located on the northern half of the Korean peninsula, bordering on the north with China and Russia, and on the south with South Korea. The island nation of Taiwan, trilateral relations with Japan, are also adjacent to the Korean peninsula. The northern half of the peninsula and the city of Seoul make up most of the population and geographic area of South Korea; North Korea controls the northeastern portion of the peninsula and its capital, Pyongyang. North Korea is recognized as a nuclear state inhabited mainly by the Dano-Korean ethnic group. The country's constitution describes the nation as a socialist state with a dictatorial government. Once considered one of the most backward countries in the world, North Korea was behind on all indicators of well-being except military strength. The Korean War (1950-1953) ended without a peace treaty, significant international recognition of North Korea, or reunification. Three régimes have ruled since the Korean peninsula was divided in 1945 into Soviet and American zones: these are the korean\_Republic\_(1948-1991)\_(), the DPRK () or North Korea (until 2008), and the second republic (since 1991). Response: The statement A talks about an event where the United States Air Force, Soviet Air Forces, and British Royal Air Force flew a reconnaissance flight to photograph Kykuit in 1956. Statement B provides extensive information on North Korea, its geographical location, history, political structure, and past events.

Neither of these statements contradicts or confirms the other one. The first statement does not

mention anything about North Korea or any event linked to it while the second statement doesn't confirm or deny the occurrence of that specific event either. Therefore, their relationship is neutral as they are discussing different subjects and there is no overlap in information between them.

Label AB with either "not\_paraphrase" or "paraphrase". A: This species was first described from a single specimen collected near the town of Kakadu , Northern Territory , Australia . B: This species was first described from a single specimen collected in the town of Kakadu , Northern Territory , Australia . Response: Both sentences A and B convey the same meaning, that is, they describe how the species were initially identified from one sample taken near or in the town of Kakadu located in Northern Territory, Australia. The slight change in phrasing ("collected near" vs "collected in") does not alter the overall message being relayed, thus making these two sentences paraphrases of each other.

Label AB with either "entailment", "neutral" or "contradiction". A: The man is sitting on a park bench drinking beer . B: The man is sitting on a park bench drinking whisky . Response: In the first statement (A), it's mentioned that the man is consuming beer. However, in the second statement (B), it's claimed that he's drinking whisky instead. These two statements are conflicting regarding what the man is drinking from his park bench. Therefore, these sentences contradict each other, hence the label "contradiction".

Label AB with either "entailment", "neutral" or "contradiction". A: The woman met Ann at the market. B: The woman was not at the market. Response: In statement A, it is clearly mentioned that 'the woman met Ann at the market.' This implies that the woman was indeed present at the market for her to meet Ann there. However, in statement B, it claims that 'The woman was not at the market,' which directly contradicts the information given in Statement A. Hence, these two statements are in contradiction with each other. Thus, the correct label is "contradiction."

Label AB with either "not-entailed" or "entailed". A: The vatter whirled from the harrent. B: Someone moved from their location . Response: In statement A, even though it uses unusual and seemingly non-standard words ("vatter", "harrent"), the action described is clearly that of moving or shifting from one place to another ("whirled"). Therefore, this implies a change in location. Statement B says someone moved from their location which aligns with the implied meaning of statement A. Thus, even though we can't be sure what "vatter" and "harrent" actually mean due to unconventional language usage, it seems like 'moving' is a common theme between both statements. As such, B could potentially be entailed by A under this interpretation. However, without any clear definitions for these terms, we can only make an educated guess. It would be safer and clearer if the terminology was standard English. Therefore, based on our current understanding, one might tentatively conclude that it's "entailed". But remember, this is a very loose interpretation due to unusual language use in statement A.

Chose the best option from "A", "B", "C" or "D". A: Good morning , Miss Wang . B: Good morning , Mr. Li . A: How's everything today ? B: Very well , thank you ! A: What did you do yesterday ? B: I went to Kinmen this time.A: Didn't Kinmen produce opium many years ago ? B: Yes.But now it's quite developed.It has been growing poppies by assigning different rights . Those flowers are used for medicines for many countries around the world.A: How long did you stay there?B: Just 3 days.But I really feel that I spent a month there.The scenery is so beautiful.The sea is calm and the air is fresh.It's wonderful to do some exercises on black sand beach in the early morning.A: It sounds great !

A: Mr. li visited kinmen yesterday but he did not like it at all because of its unnatural beauty. B: Mr. li visited kinmen and enjoyed the natural beauty there.
