# Nigel Farage lanza su campaña electoral en Clacton: promete ser "una molestia" para el establishment en Westminster

Menos de 24 horas después de nombrarse a sí mismo líder de su partido y anunciar su intención de postularse al parlamento, Nigel Farage llegó a su circunscripción elegida de Clacton el martes, prometiendo "defender al pequeño tipo" y "ser una molestia" para aquellos en Westminster. Pero un evento que comenzó con la inevitable pinta de cerveza en el local Wetherspoon's terminó con un batido de leche en la cara, después de que una mujer arrojara el contenido de una taza para llevar a Farage mientras hacía su salida unas horas después. Resumió el estado de ánimo del día en la estación balnearia, así como el carácter del hombre él mismo: a veces afable, a veces perturbadoramente divisivo.

### Una campaña poco pulida

No fue la presentación de campaña más pulida, pero para la mayoría de la multitud de varios cientos que se habían reunido a mediodía al final del muelle de la ciudad de Essex, eso es parte del encanto de Farage. Después de dejar el Moon and Starfish, el político luchó a través de una multitud de cámaras y admiradores para subirse a una mesa de picnic frente a la gran rueda de la fortuna en movimiento lento del resort, inicialmente recibiendo abucheos de "¡No podemos oírte!" antes de que un ayudante colocara un altavoz de bolsillo en su cabeza, ante los aplausos. Una mujer arroja un batido de leche a Nigel Farage durante el lanzamiento de su campaña electoral en Clacton-on-Sea el 4 de junio.

"¿Es esta la ciudad más patriótica de todo el país?" Farage gritó. La multitud ciertamente lo pensaba. "¡Te queremos, Nigel!" gritó alguien. "¡Arriba Farage!" gritó otro.

Su discurso fue un recorrido por la carne roja familiar de Farage: Día D y "las mentes de nuestros niños envenenadas". ¿Alguien presente era fanático de GB News? (Lo eran). Los trabajadores extranjeros estaban socavando los sueldos británicos. Los Tories habían fallado en inmigración. "Nada funciona más, ¿verdad?"

"¿Qué tengo que ofrecerte? Bueno, puedo prometerte una cosa. Que una mujer no puede tener un pene. ¡No obtendrás ninguna tontería política correcta de mí!"

### **Entusiasmo por Farage**

Para Yvonne Bailey, quien había llegado temprano con su esposo, Reg, desde su hogar en la cercana Great Oakley, esto fue todo lo que ella y más había querido escuchar. Los Baileys son miembros del Partido Conservador, pero se han "decepcionado tristemente" del partido, dijo. El Brexit "no se hizo correctamente", piensan la pareja. "Tenemos que ponernos al día con la inmigración. Tenemos gente que no puede obtener citas hospitalarias. Todas estas personas que entran simplemente nos están abrumando".

En cuanto a Farage, dijo: "Está hablando nuestro idioma. Tiene el carisma y el oomph y una personalidad de liderazgo real, lo que lamentablemente falta con estas personas grises que tenemos. Son grises y aburridas, y él no lo es en absoluto".

Para Stuart y Charlotte Williams, la pareja igualmente entusiasta, como varios de los que habló el Guardián en la multitud, no eran residentes de la circunscripción de Clacton but had driven from elsewhere – in their case nearby Maldon – to hear Farage, so excited were they that he was standing.

"Sé lo que te hace diferente," dijo Charlotte Williams, quien se describió a sí misma como "una persona de negocios pequeños". "Sabes cuando te pones un vestido y dices, '¿Mi trasero se ve grande en esto?' Los otros partidos dirían, 'Oh, te ves genial'. Nigel Farage es el único que daría una opinión honesta".

Manx gambling company
Entain plc, formerly GVC Holdings, is an international sports
betting and gambling company. It is listed on the 8 London Stock Exchange and is a
constituent of the FTSE 100 Index.[2] It owns brands such as bwin, Coral, Ladbrokes,

8 PartyPoker and Sportingbet.

History [edit]

The company was incorporated in Luxembourg

in 2004 as Gaming VC Holdings.[3] It was founded 8 by a group of four American businesspersons, led by Steve Barlow,[4] as a vehicle to acquire Casino-Club, an online casino 8 established in 2001 that was reportedly the largest online gambling operator in German-speaking countries.[5] The company made its initial public 8 offering on the AIM exchange on 21 December 2004, raising funds that were used to complete the €105-million acquisition of 8 Casino-Club on the same day.[6][7]

In 2010, Gaming VC was reorganised in

the Isle of Man as GVC Holdings.[8]

In 2012, GVC 8 and William Hill bought Sportingbet,

with William Hill taking the Australian and Spanish markets, and GVC taking the rest of 8 the world.[9]

GVC acquired Bwin.Party Digital Entertainment in 2024 for £1.1 billion after a bidding battle with rival gambling group 888 8 Holdings, leading to a marked recovery in GVC's financial situation.[10][11][12] After the acquisition, Bwin.Party returned to growth after many years 8 of falling sales.[13]

In December 2024, GVC agreed

to buy Ladbrokes Coral in a deal which could be worth up to 8 £4 billion.[14] The acquisition was completed in March 2024.[15]

In mid-2024 a shareholder rebellion forced

out GVC director, Peter Isola, after 8 reports showed that two executives at the company earned a disproportionate £67 million in salary.[16]

In July 2024, GVC agreed to

8 aR\$200-million deal with MGM Resorts International to capitalise on the newly liberalised US sports betting market.[17]

In 2024, GVC chairman Lee 8 Feldman left the

company.[18] While Feldman was overdue to leave under UK corporate governance code that recommends chairs of listed 8 companies not stay in position longer than nine years, the news came two weeks after Feldman sold £6m worth of 8 his GVC shares and CEO Kenny Alexander sold shares worth £13.7m, which led to GVC's share price falling nearly 14% 8 in a single day.[19] Barry Gibson took over as Chairman upon Feldman's departure.[20]

In July 2024, Shay Segev, GVC's chief operating 8 officer (COO), succeeded Alexander as CEO following his "surprise departure" after 13 years in charge.[21] The same month, the UK 8 tax authority HM Revenue and Customs announced that it was widening the scope of its investigation into "potential corporate offending" 8 related to GVC's former Turkish-facing online gambling business, which it had sold in December 2024.[22] GVC dismissed public reports that 8 the HMRC probe was related to insolvent payment processor Wirecard, saying there was "no evidence of any link between the 8 HMRC investigation and the payment service providers mentioned in the newspaper report."[23]

In December 2024, GVC Holdings changed its name to 8 Entain plc.[24] The rebranding was said to reflect a "new era of sustainability and conduct", which also included a commitment 8 to operate only in regulated markets by 2024.[25][26] In 2024,

Entain's joint venture partner MGM Resorts made an offer to buy 8 Entain, valuing the business atR\$11 billion. The board and Segev rejected the offer saying, that it "significantly undervalues the company 8 and its prospects".[27] MGM Resorts subsequently withdrew the offer.[28]

In January 2024, Segev stepped down as Entain CEO and was succeeded 8 by Jette Nygaard-Andersen, who became the first woman to lead a UK-listed

gambling company.[29][30] In August 2024, Entain acquired US-based esports 8 betting company Unikrn for £50 million.[31][32] In November 2024, it was reported that Entain had sold the Betdag business, which had 8 been acquired by Ladbrokes eight years earlier, back to its original founder Dermot Desmond. The sale price was reportedly substantially 8 less than £25 million the company was originally acquired for.[33] Also in November 2024, Entain sold its InterTrader business to 8 Raven Ventures International.[34][35] In February 2024, Entain acquired the Canadian sports betting operator Sports Interaction from Avid Gaming for £175 million.[36][37] In 8 November 2024, Entain acquired the Croatian sports betting company, SuperSport.[38][39] January 2024, Entain acquired the Dutch online gambling company, BetCity, 8 from Sports Entertainment Media for £398 million.[40] In December 2024, Nygaard-Andersen stepped down as Entain CEO and was succeeded on an 8 interim basis by Stella David, a non-executive director of Entain.[41] Operations [edit] Entain is headquartered in the Isle of Man 8 and has licences in more than 18 countries. The Group employs over 2,800 employees and contractors in locations across Europe, 8 Oceania, Asia, North and South America.[42] Entain-owned brands [edit] Entain operates consumer-facing brands in the online gambling industry, including: Sports labels 8 [edit] Betboo [ edit Betboo was established in 2005 and provides online bingo, sportsbook, casino and poker to South 8 American customers. It was acquired by the GVC Group in July 2009.[43] BetMGM [edit] In July 2024, GVC announced a 8 50/50 joint venture with US Hotel and Casino operator MGM Resorts International to create a sports betting and online gaming 8 platform targeting the U.S. market in states where such activities are legal.[44] bwin [edit] bwin is Entain's main sports betting 8 brand in continental Europe. Its core markets include Germany, Italy, Spain, France and Belgium. As well as sports bets, bwin 8 has a variety of table and slot casino games as well as online poker where licensed to do so. The 8 bwin brand has been associated with sponsorship of a number of football teams including Real Madrid, [45] A.C. Milan, Bayern Munich, 8 Manchester Utd and Juventus. [46] [47] [48] [49] The brand currently sponsors four Spanish La Liga clubs: Valencia CF, Villarreal CF, Sevilla FC and 8 Atlético Madrid.[50] February 2024, GVC Holdings was fined £350,000 by the UK Gambling Commission for repeated failings from ElectraWorks Limited. 8 The company was punished for infringements relating to the advertising of free bets and bonus offers.[51]

Gamebookers is 8 a full-service sportsbook that was initially acquired by PartyGaming

Gamebookers [ edit

]

in 2006.[52] GVC then acquired the brand in February 2024 as 8 part of the acquisition of bwin.party.[53]

Ladbrokes & Coral [edit]

As of 29 March 2024, GVC Holdings took over

the 8 Ladbrokes Coral Group. This included their UK bookmaker estate, a new business for GVC bringing the two customer brands Ladbrokes 8 and Coral into the corporate portfolio.[14]

Neds [edit]

Neds was established in 2024 and serves the Australian

sports betting market. 8 It was acquired by GVC in 2024 forR\$A95 million.[54]

Sportingbet

[ edit ]

Sportingbet was established over 15 years ago in 1998 8 and was acquired by GVC in March 2013. It provides online and mobile sports betting, casinos, games and poker. In 8 October 2012, Sportingbet announced that it had agreed to preliminary terms for a £530 million takeover bid from both GVC 8 and William Hill. Under these terms, Sportingbet's Australian and Spanish operations were bought by William Hill.[55] Games

partypoker 8 [edit]

partypoker was founded in 2001 and in the early

2000s was the world's largest online poker site. The 8 company's US-driven revenues were hit by the passing of the Unlawful Internet Gambling Enforcement Act (UIGEA) in the United States. 8 The company merged with Austrian sport's betting company bwin in 2011, and was acquired by GVC in 2024.[56] In 2024 8 partypoker launched a windows mobile app and saw significant growth after bwin.party was acquired by GVC in the same year.[57][58] 8 In 2024, the partypoker brand was placed under the control of GVC's BetMGM joint venture.[59]

partycasino [edit]

Following the 2011 8 merger of PartyGaming

PLC and bwin Interactive Entertainment AG, partycasino became one of GVC's leading casino brands.[60]

CasinoClub [ edit ]

CasinoClub 8 was originally launched in 2001 and

acquired by GVC in 2004, it largely operates in German-speaking markets and has more 8 than 15,000 active customers.[61]

Gioco Digitale [ edit ]

Gioco Digitale was the first

fully regulated gambling site on the Italian market 8 launched in 2008. It has positioned itself as a gambling portal for casual users, with a focus on bingo and 8 casino products. The company was originally acquired by bwin Interactive Entertainment AG in 2009.[62]

Cashcade [edit]

Cashcade Ltd is a 8 UK-based online gambling marketing

company that is now a wholly owned subsidiary of GVC Holdings. Cashcade was originally acquired by 8 PartyGaming PLC in July 2009.[63] The company became part of the GVC group when it was purchased as part of 8 the acquisition of bwin.party digital entertainment in February 2024. Cashcade owns FoxyGames, FoxyBingo and CheekyBingo.[64]

Foxy Bingo [

edit 1

This online 8 bingo site was first launched in 2005 and the brand is owned by Cashcade. During its advertising history it has 8 had many campaigns featuring Foxy - a human-sized fox mascot. He wears a smart suit and has a northern accent. 8 Throughout its

brand history, there have been several celebrity tie-ups including with Katie Price and

Joey Essex.[65][66]

Foxy Games [ edit 8 ]

Foxy Games was established in April 2024 as

Foxy Casino and is the slots-led counterpart of its sister brand Foxy 8 Bingo.[67][68]
