Administering the National Health Care System (NHCS) in Singapore involves several key departments that work collaboratively to ensure high-quality healthcare delivery and efficient use of resources. Here is a breakdown of these departments:

- 1. Ministry of Health (MOH): The MOH oversees the entire NHCS, formulates policies, sets standards, and ensures effective management and coordination between all stakeholders in the healthcare sector. It also allocates resources and develops strategies for continuous improvement in quality care delivery.
- 2. Health Promotion Board (HPB): HPB is responsible for promoting a culture of healthy living through education, awareness campaigns, and community outreach initiatives. They focus on preventive healthcare measures to reduce the incidence of chronic diseases and other health issues.
- 3. Central Provident Fund (CPF): CPF serves as Singapore's social security scheme designed to provide financial support for its citizens in their retirement, housing needs, and healthcare expenses. - 4. Agency for Integrated Care (AIC): AIC is tasked with the administration of Singapore's longterm care system (LTC). Its primary goal is to ensure seamless integration across different levels of healthcare, such as home-based care, community-based services, and inpatient facilities.
- 5. National Healthcare Group (NHG): As a not-for-profit organization, NHG delivers quality healthcare services under contracts with the Ministry of Health. It comprises three hospitals -Parkway East, Mount Elizabeth Novena, and Yishun Community Hospital - along with several polyclinics spread across Singapore.
- 6. National University Health System (NUHS): A joint venture between NUS Medical School and SingHealth Group, the NUHS offers healthcare services to the public while promoting

medical education. It operates three hospitals in Ang Mo Kio, Toa Payoh, and Jurong East areas.

- 7. National Health Services (NHCS): This is a network of 16 community health centers located throughout Singapore that provide primary care services such as general medicine consultations, immunizations, screening for chronic conditions like diabetes or hypertension, and treatment for minor injuries and illnesses.
- 8. National Emergency Medical Services (NEMS): NEMS provides 24/7 ambulance service across Singapore to transport patients in need of urgent care quickly and safely. The team consists of paramedics, emergency medical technicians, and clinical nursing officers who work together to provide critical prehospital interventions during the initial stages of trauma or illness.
- National Registration Department (NRD): While NRD primarily handles identity verification for various applications, it also plays a role in ensuring accurate medical records by integrating with other government agencies such as Immigration and Customs, Ministry of Manpower, and Housing Development Board.
- 10. Singapore Health Services (SingHealth) Public hospitayer: SingHealth operates six public hospitals, four specialty centers, and three community healthcare institutions to provide a wide range of inpatient and outpatient services nationwide. Its key objectives include promoting research and innovation, improving patient care through evidence-based practices, optimizing resource allocation, and strengthening partnerships with other stakeholders in the public and private sectors.
- 11. Ministry of Sustainability and Development (MSD): MSD supports long-term sustainable development goals by integrating environmental considerations into healthcare planning and operations. This includes ensuring adequate funding for green initiatives, promoting energy efficiency in medical facilities, developing policies to address climate change impacts on public health, and facilitating collaboration between government agencies and the private sector.
- 12. Health Promotion Board (HPB): HPB takes an active role in encouraging healthy lifestyles among Singaporeans through various campaigns focused on nutrition, exercise, mental wellness, substance abuse prevention, and environmental factors affecting health. It collaborates with community organizations, schools, workplaces, and other stakeholders to reach a wider audience.
- 13. National Kidney Foundation (NKF): NKF provides care for patients suffering from chronic kidney diseases at its two main clinics in Queenstown and Sengkang as well as satellite centres throughout Singapore. The organization also offers educational programs, support groups, and research initiatives to enhance patient outcomes while working closely with the Ministry of Health on policy recommendations related to this field.
- 14. National Heart Centre Singapore (NHCS): As part of its mission to improve cardiac care accessibility for all residents across the country, NHCS delivers comprehensive services including advanced diagnostics and treatment options through its flagship facility located in Bukit Timah Road. It also collaborates closely with other hospitranals and community-based providers to ensure a seamless continuum of care.
- 15. Health Promotion Board (HPB): HPB takes a holistic approach towards health promotion by addressing lifestyle factors that contribute significantly to chronic diseases prevalent among Singaporeans today, such as heart disease, diabetes mellitus type 2, and certain types of cancer. This encompasses initiatives targeted at promoting physical activity, nutrition education programs for children & adults alike, smoking cessation support services, mental wellness awareness campaigns, stress management workshops among others all aiming

to reduce the burden on Singapore's healthcare system over time.

- 16. Institute of Mental Health (IMH): IMH plays a critical role in providing comprehensive psychiatric care and rehabilitation services for individuals with mental illnesses across different stages of their lifecycle, from early intervention to long-term community support. In collaboration with other government agencies like the Ministry Of Social And Family Development (MSF), it also focuses on preventive measures through initiatives such as public awareness campaigns regarding depression and suicide prevention strategies tailored specifically towards vulnerable populations including elderly citizens or those living below poverty lines.
- 17. Singapore Armed Forces Medical Corps (SAFMC): SAFMC is responsible for delivering medical support to the armed forces personnel, veterans, and their dependents through various outpatient clinics, inpatient wards within military bases as well as specialized services catering exclusively towards those who have served in the Singapore Armed Forces (SAF). The organization also collaborates closely with civilian hospitals when necessary to ensure optimal care for servicemen suffering from injuries sustained during their service.
- 18. Agency for Integrated Care (AIC): AIC manages a network of long-term community care centers whereby residents receive assistance in daily living activities, rehabilitation services, and other healthcare needs that cannot be met within hospitals or polyclinics due to their chronic conditions being managed primarily outside of these facilities. The agency also works alongside government agencies like the Ministry Of Social & Family Development (MSF) and local community organizations to coordinate care plans for individuals living with disabilities, older adults requiring nursing home placements or assistive devices, children with special educational needs etc., thus ensuring continuity of care across different stages.
- 19. Health Promotion Board (HPB): HPB takes a proactive stance towards addressing the root causes behind lifestyle-related chronic diseases prevalent among Singaporeans today by promoting healthy living through initiatives that focus on physical activity, nutrition education programs for children & adults alike, smoking cessation support services, mental wellness awareninasm campaigns and stress management workshops.
- 20. Health Promotion Board (HPB): HPB actively promotes healthy lifestyles through various initiatives including public awareness campaigns on diet & exercise, nutrition education programs targeting children & adults alike; smoking cessation support services via helplines or community-based interventions; mental wellness workshops aimed at reducing stress levels among participants; and strategies to address obesity such as subsidized gym memberships/programmes. It also collaborates closely with other stakeholders including government agencies, schools & private organizations for better implementation results.
- 21. Agency For Integrated Care (AIC): AIC is tasked with delivering comprehensive long-term community care services to meet the needs of Singaporeans who are unable or unwilling to receive such care within hospital settings due to their chronic conditions being managed primarily outside hospitals & polyclinics respectively. The agency works closely together with other government bodies like Ministry Of Social And Family Development (MSF) as well as non-profit organizations involved in elderly support services across different levels from basic daily living activities such as assistance with bathing, dressing or mobility issues caused by illnesses related to dementia; through advanced interventions involving palliative care options including hospice facilities offering round-the-clock respite home nursing programs etc., thereby ensuring continuity of care across different stages for those who require ongoing support.

- 22. Ministry Of Health (MOH): The ministry's primary responsibility is to provide leadership and direction in the development of health policies, regulations, standards & guidelines; oversee implementation thereof by public hospitals, polyclinics & private providers under its purview while also ensuring accountability through regular monitoring & evaluation processes. Health Promotion Board (HPB): HPB is the government body responsible for leading Singapore's efforts in promoting a culture of wellness among its citizens by implementing comprehensive initiatives aimed at encouraging them to adopt and maintain healthy lifestyle choices such as regular exercise, balanced diets; smoking cessation programs etc. Furthermore, it also engages various stakeholders like schools, community groups & corporations through workshops/seminars focused on educating these segments about best practices related to overall well-beinasm promotion thus contributing towards creating an environment conducive for individuals across all age brackets within Singapore society who may need additional support in leading a healthy life.
- 24. Ministry Of Health (MOH): The Ministry of Health, which oversees the nation's entire public health system including hospitals and clinics, has developed several programs aimed at improving patient care quality through standardizing processes across different facilities while also focusing on reducing waiting times for patients seeking medical attention.
