Calendário da segunda rodada dos playoffs 2024 do NBB, que começará na quinta-feira, 2 de maio de 2024. Os confrontos incluem Flamengo (1º) x Botafogo (16º), Sesi Franca (2º) x Mogi Basquete (15º), e Minas (3º) x União da Ilha dos Pontões.

A partir desta data, os playoffs progredirão com jogos mais intensos, onde as equipes se enfrentarão até chegar à decisão final do campeonato. O público pode assistir aos jogos em campeonato mato grossense 2024 vários locais, dependendo da localização dos times. O NBB (Novo Basquete Brasil) fornece horários e locais para os eventos oficiais, que incluem a televisão e as plataformas online.

A tabela completa com todos os confrontos é divulgada pela Liga Nacional de Basquete, e o público também pode assistir aos jogos em campeonato mato grossense 2024 vários canais de transmissão ao vivo.
