Knowing that my accounts are fully registered in said casino, I sent the pertinent documents again today to see what nonsense I get this

time. Continuing with my story, a while ago I also made a withdrawal of 23,000 Swiss Francs. Now it is only possible to wait for them to be sensible and comply by sending me the cash withdrawn; otherwise I will have to file a complaint to see if the casino deigns to do its job, which at the moment is not pleasant for me. In short, I am just waiting to see if they comply with their motto: withdrawals at 20bet casino are extremely fast within 24 hours. Gentlemen of the 20bet casino, I know that for one reason or another you will read the content of my comment, I urge you: do your duty, and do not be scamming people everywhere, there are already thousands of negative reviews on different websites. You do not know that you yourself are damaging by affecting your already decayed reputation; by acquiring so many negative reviews against it. After all, the scam is persecuted worldwide and of course; the boldest fish falls sooner or later into the net.

Hola a todos, quiero exponer mi caso e indagar un poco sobre mi experiencia en este extraño casino 20Bet. Hace pocos días, empecé a jugar en este casino, primero hice mi primer depósito y luego otro; a través de dos tarjetas de créditos. También deposité efectivos a través de mis cuentas registradas de Skrill y Netteller. Antes de eso verifiqué mis tarjetas, una fue rechazada y la otra aceptada. Yo envié extractos bancarios de mis tarjetas de crédito, luego le hice [jogos que ganham dinheiro de verdade no nubank](#) a mis dos tarjetas de créditos. Por otra parte, envié capturas de mis cuentas registradas de Skrill y Netteller, con ello procedió el soporte a verificar mis documentos, hasta aquí todo bien. El problema empezó entonces cuando solicite retirar esos 24.000 francos, yo pensando que todo iba bien es decir de lujo me quede tranquilo; luego al pasar un rato me envió en soporte unos cuantos correos diciéndome sin especificar mucho: su solicitud de retiro ha sido rechazada el motivo: sus tarjetas tienen que mostrar nombre de destinatario, números dígitos etc. Yo digo: o estos son tontos o se hace los pendejos; porque primeramente me verificaron las cuentas puesto que todo estaba más claro que el agua. Yo, a sabiendas de que mis cuentas están totalmente registradas en dicho casino, volví a enviar hoy día los documentos pertinentes para ver conque tonterías me salen esta vez. Prosiguiendo pues con mi relato, hace un rato también volví a realizar un retiro 23.000 Francos Suizos. Señores del casino 20bet, sé que ustedes por una u otra razón leerán el contenido de mi comentario, les pido encarecidamente: cumplan con su deber, y no estén estafando a las personas por doquier, ya son miles las reseñas negativas en diferentes sitios web. Ustedes no saben que ustedes mismo dañan afectando su ya decaída reputación; al adquirir tantas reseñas negativas en su contra. Después de todo, la estafa es mundialmente perseguida y como no; el pez por más audaz que sea cae tarde o temprano en la red.
